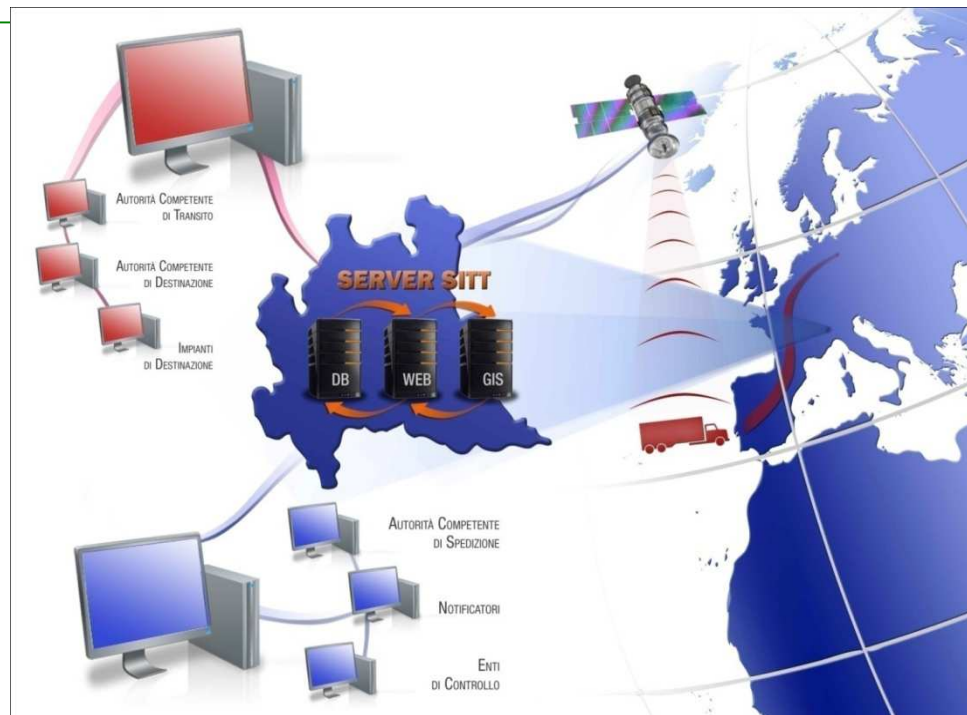


## S.I.T.T. The Information System for the Transboundary Shipment of Waste by Regione Lombardia

- Best practice for simplification in the Local Government
- Tool for full trackability of waste shipment via Satellite Positioning Systems



The rules supervising the transboundary shipment of waste derive from **Regulation n. 1013/2006/** of the European Parliament and the Council. Such Regulation establishes the procedures and control measures for waste shipment as a function of origin, destination and transit; of the nature of the shipped waste; of the kind of treatment that the waste is to undergo at the destination plant.

Article 3 defines a general procedure framework for waste shipment within the European Union. In particular, the waste types to be notified and authorized on paper before shipment and those subjected, instead, to more generic information duties, are defined.

## S.I.T.T. The Information System for the Transboundary Shipment of Waste by Regione Lombardia

- ➔ **Project conceived since 2006**
- ➔ **From April 1°, 2010 to April 30, 2012 (25 months): experimental phase, involving up to 60% of the enterprises based in Lombardy and active in the transboundary shipment of waste**
- ➔ **From May 1°, 2012 (8 months): mandatory use of S.I.T.T. for all the enterprises based in Lombardy and active in the transboundary shipment of waste**
- ➔ **Possible implementation by other government institution and agencies (Italian Regions /Autonomous Provinces or Ministry for the Environment, central or regional administrations of other partner States in the UE...)**
- ➔ **Prolonged experimental phase before enforcing the method; direct dialogue with the users in the experimental and implementation stages of the process**
- ➔ **Use of low-cost GPS devices, that however ensure high precision and reliability due to the employment of permanent GPS stations**

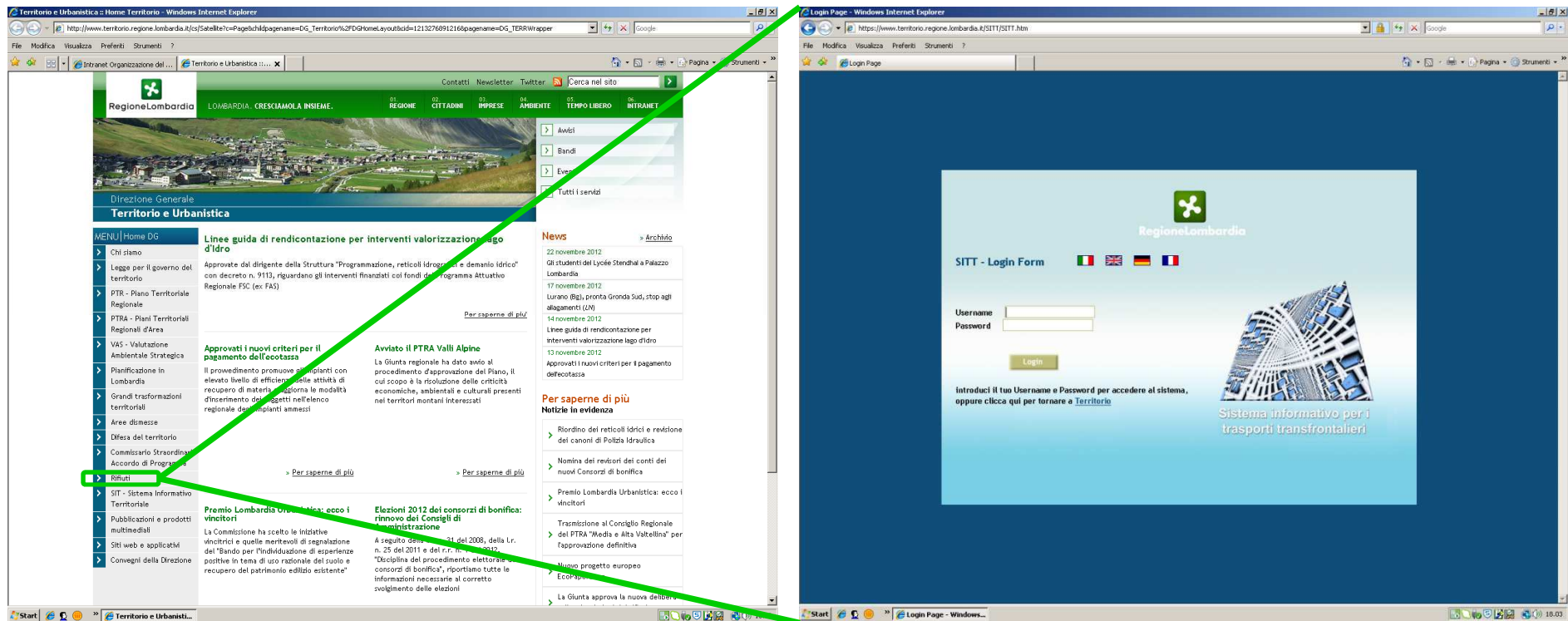
